AN OFFICIAL TIMEKEEPER WILL BE PRESENT DURING THE STATE YOUTH TALENT FINALS. ALL ACTS SHOULD COME PREPARED WITH ANY NECESSARY EQUIPMENT TO PERFORM, SUCH AS MUSIC STANDS AND INSTRUMENTS AS THE STATE FAIR DOES NOT PROVIDE THESE ITEMS.
